GMS403: Global Business Environment

Course Description

The course is an introduction to international business environment, which focuses on key global business environmental factors and issues that affect firms with international operations. Factors to be investigated include areas such as foreign market entry and the role of multilateral institutions. The main topics covered are: the development of firms with international operations, including multinational enterprises; national differences in the economic, political, cultural, social and legal environments (including a particular focus on doing business in developing and transitional economies); cultural differences and their effects on international business; the operation of foreign exchange markets; international trade policy and the World Trade Organization (WTO); regional economic integration; and the impact of technology.

Prerequisite: None.

Course Objectives

By the end of this course, students will be able to:



1. Understand and analyze current geopolitical challenges and their impact on the global business environment.

2. Identify and evaluate supply chain issues arising from the globalization of economies and their implications for businesses and society.

3. Make informed strategic decisions regarding foreign market entry and understand the role of multilateral institutions in international business.

4. Develop insights into conducting business in key geographic regions, including Europe, Asia, Latin America, Africa, and the Middle East.

5. Assess the influence of cultural, political, and economic factors on business practices in different regions through lectures and classroom discussions.

Course Hours

The course has 25 class sessions in total. Each class session is 110 minutes in length, for a total of 2750 minutes of in-class time. The course meets from Monday to Friday.
